SUBJECT: Equal Opportunity Goals for Minorities and Women

Under authority established in Section 18701, Government Code, and pursuant to Government Code Section 11346.8(c), the State Personnel Board (Board) is giving notice of the opportunity to submit comments on modifications that are being considered regarding the above-named regulations.

On February 9, 2000, the Board held a Public Hearing to consider revisions to the California Code of Regulations. The Board received oral and written comments on the proposed revisions. On May 4, 2000, an informal discussion was held at Board headquarters to which all commenters were invited. Part of the regulations have been modified as a result of comments received at the February 9, 2000 hearing and at the informal discussion on May 4, 2000.

A copy of the full text of the regulations as originally proposed, with the modifications clearly indicated, is attached for your information. The regulations as modified will be presented for adoption at the July 6, 2000, meeting of the Board.

The Board's rulemaking file on the proposed action is open to public inspection by appointment Monday through Friday, from 8:00 a.m. to 5:00 p.m., at the Board's Office, 801 Capitol Mall, Room 555, Sacramento, California.

In the original December 14, 1999 notice for this action, the document, *Recommended Procedures For Establishing Equal Employment Opportunity Goals and Timetables*, revised March 1999, by the State Personnel Board, was listed as one of the Documents Relied Upon. It should also have been listed as a Document Incorporated By Reference.
