SUBJECT: NEW REQUIREMENT: ALL STATE AGENCIES TO POST

**EXAMINATION AND JOB ANNOUNCEMENTS ON SPB'S WEBSITE** 

In order to provide a centralized portal for state jobs, all future civil service examination and job announcements must be posted on the State Personnel Board's (SPB) website at: <a href="http://www.jobs.ca.gov">http://www.jobs.ca.gov</a>. This requirement applies to examination announcements for all civil service classifications, including CEAs, and applies to job announcements for all civil service, CEA, seasonal, and other non-testing classes (i.e. Youth Aid and Student Assistant). Boomerang (<a href="https://boomerang.ca.gov/">https://boomerang.ca.gov/</a>) continues to be available as a resource to recruit for Retired Annuitants.

Although hiring departments have not been required to post job announcements on SPB's website in the past, departments that have utilized the website have found it to be a useful vehicle for developing a substantial pool of qualified applicants. Current state employees and the general public will now be able to search for exams and jobs at one location. SPB's website also provides helpful tools and information to aid candidates through the state examination and hiring process.
