Dear Steve Taketa,

The State Personnel Board (Board or SPB) conducted a baseline compliance review of the (BSCC)'s examinations, appointments, EEO program, and personal services contracts during the period of May 2011 through December 2012. The primary objective of the review was to determine if BSCC's personnel practices, policies, and procedures complied with state civil service laws and board regulations, and to recommend corrective action where deficiencies were identified.

BSCC provided the documents that SPB requested. A cross-section of BSCC's examinations, appointments, EEO, and personal services contracts were selected for review to ensure that samples of various examinations and appointment types, classifications, and levels were analyzed. The review of the EEO program included examining written policies and procedures, the EEO officer's role and duties, and the internal discrimination complaint process. The SPB also interviewed appropriate BSCC staff.

The Compliance Review Division (CRD) has found no deficiencies in the review of BSCC's administration of examinations, appointments, EEO program, and personal service contracts). The CRD will submit its findings to the five member State Personnel Board and recommend adoption. The Board will issue a resolution either adopting these findings or issuing its own findings and order. In either event, you will be notified of the Board's action. The final Board action will be posted on the SPB's website.
