Dear Mr. Rowe,

The State Personnel Board conducted a baseline compliance review of the State Compensation Insurance Fund (SCIF)'s appointments during the period of May 1, 2011 through October 31, 2012. The primary objective of the review was to determine if the SCIF's personnel practices, policies, and procedures complied with state civil service laws and board regulations, and to recommend corrective action where deficiencies were identified.

The SCIF provided the documents that SPB requested. A cross-section of the SCIF's appointments was selected for review to ensure that samples of various appointment types, classifications, and levels were analyzed.

The Compliance Review Division (CRD) has found no deficiencies in the review of the SCIF's administration of appointments. The CRD will submit its findings to the five-member State Personnel Board and recommend adoption. The Board will issue a resolution either adopting these findings or issuing its own findings and order. In either event, you will be notified of the Board's action. The final Board action will be posted on the SPB's website.
