SUBJECT: PEACE OFFICER CLASSIFICATION SPECIFICATION CITIZENSHIP

REQUIREMENTS CLARIFICATION

## **Purpose**

This memo provides interim guidance to departments on evaluating candidates for peace officer classifications considering statutory changes that eliminate outdated citizenship requirements.

# **Background**

Effective January 1, 2023, <u>Senate Bill (SB) 960</u> amended <u>Government Code section</u> 1031, subdivision (a), to read:

"Each class of public officers or employees declared by law to be peace officers shall meet all of the following minimum standards: (a) Be legally authorized to work in the United States under federal law."

This amendment removes the prior requirement that peace officers be U.S. citizens or permanent residents seeking citizenship. Non-U.S. citizens may now qualify for peace officer positions if they are legally authorized to work in the United States under federal law.

### **State Personnel Board Actions**

At its meeting May 12, 2025, the State Personnel Board (SPB or Board) addressed the conflict in many minimum qualifications (MQ's) for civil service peace officer classifications and the amendments to law proscribed in SB 960. It adopted a resolution (attached) which provided that all candidates for peace officer classifications listed in the

resolution shall only be required to be legally authorized to work in the United States under Federal law, regardless if the MQ's in the classification specification state otherwise.

Furthermore, the California Department of Human Resources (CalHR) was tasked to review and revise peace officer classification specifications and present the amendments to the Board no later than the August 2025 Board meeting. If CalHR determines that a specific classification specification should require citizenship, it must present its rationale to the Board for that determination.

# **Interim Guidance for Departments**

Until classification specifications are officially updated, departments must take the following steps to ensure compliance with Government Code section 1031, subdivision (a), and the Board's May 12, 2025, resolution:

- Discontinue use of outdated citizenship or permanent residency requirements when evaluating peace officer candidates listed in the Board's resolution.
- Verify legal authorization to work in the United States using standard employment eligibility procedures (e.g., Form I-9).
- Update examination bulletins, job postings and recruitment materials to remove outdated references to citizenship requirements and replace them with language aligning with Government Code section 1031, subdivision (a).
- Train hiring managers and human resources staff on the updated eligibility requirements to ensure consistent application of the updated requirements.
- Coordinate with CalHR for assistance with specific classification or hiring concerns pending formal updates to classification specifications.

## RESOLUTION

WHEREAS, Government Code section 1031, sets minimum standards for "public officers or employees declared by law to be peace officers....";

WHEREAS, by amendment effective January 1, 2023, the minimum standards changed under Government Code section 1031, subdivision (a), <u>from</u> requiring California peace officers to be a "citizen of the United States or a permanent resident who [are] eligible for and [have] applied for citizenship, except as provided in Section 2267 of the Vehicle Code, <u>to</u> now requiring peace officers to "[b]e legally authorized to work in the United States under federal law",

WHEREAS, the specifications in the peace officer classifications as set forth in the chart below still include the U.S. citizenship requirement as reflected in Government Code section 1031 before the 2023 amendment,

WHEREAS, the California Department of Human Resources (CalHR) has yet to prepare or present its proposed revision to the peace officer classifications to comport with the 2023 amendment to Government Code section 1031,

WHEREAS, the Board finds this change necessary to effectuate the purpose of the amendment to Government Code section 1031, subdivision (a),

## IT IS RESOLVED AND ORDERED THAT:

All civil service peace officer classification specifications listed below that currently require the candidate to be a citizen of the United States or have applied for citizenship, shall now only require the candidate to be legally authorized to work in the United States under federal law.

CalHR shall revise all civil service peace officer classification specifications and present those changes to the Board no later than the August 2025 board meeting, so each civil service peace officer classification specification includes this change. In doing so, CalHR shall comply with California Code of Regulations, title 2, sections 89 to 89.7. If CalHR recommends any of the peace officer classification specifications should require United States citizenship, it shall provide the Board with its stated explanation for why this requirement is necessary for performing the essential tasks and functions of the classification.
